- F. Roof update

- G. Lighting for signs
 - 1. Lighting is up on the signs. The west side sign light is not as bright as it could be. Brian will look at it and get a new light bulb if necessary.
- H. Court Cleaning
 - 1. Larry is maintaining the sweeper-vacuuming once a week to clean it out. Tom will reach out to a couple high school kids interested in doing the sweeping.
- I. Lockers in bathroom
 - 1. Found some nice lockers that are \$1600 a piece-bank of 6 lockers.
 - 2. Wayfair has a similar model that was \$627 per bank of 6 lockers with free shipping.
